Jynneos Vaccine Ordering for Protection Against Mpox / Update

Reason / Information:

US Army Medical Materiel Agency Distribution Operations Center (USAMMA DOC) is providing additional updated utilization and ordering guidance for the Jynneos Vaccine, previously published in MMQC-23-1248. REASON: To maximize the use of available Department of Defense (DoD) vaccines for Mpox prevention.

Disposition / Instructions:

On April 1, 2024, Bavarian Nordic commercially launched their JYNNEOS vaccine for Mpox vaccination. During the period immediately following commercialization, DoD will continue to temporarily make JYNNEOS vaccine available for Mpox vaccinations as needed.

ACTIONS NEEDED:

- 1) Military Treatment Facilities (MTFs) will continue to evaluate the demand for mpox vaccination based on the current CDC guidelines for eligibility and submit orders accordingly. Jynneos can be given to people with certain risk factors and recent experiences that might make them more likely to have been exposed to mpox. Jynneos can be given as a post-exposure prophylaxis (PEP) both to people with known and presumed exposure to mpox virus. Additionally, mpox vaccination should be offered to people with highest potential for exposure or who anticipate potential exposure to mpox.

 - b. MTFs can order adequate vaccine to cover those individuals who meet the CDC guidelines for eligibility.
 - c. Additional orders may be placed when supply is depleted.
 - d. MTFs will closely manage supply to make sure it is being utilized for the eligible population.
 - e. DO NOT order to stockpile.
- 2) If an MTF has identified a patient with an immediate need for vaccine due to exposure and do not have supplies on hand, contact Defense Health Agency Immunization Healthcare Division (DHA IHD) at 1-877-438-8222 (DSN 312-761-4245)
